PATIENT BILL OF RIGHTS

1. RECEIVE APPROPRIATE SERVICES AS PRESCRIBED IN A PROFESSIONAL MANNER WITHOUT DISCRIMINATION RELATIVE TO AGE, SEX, RACE, RELIGION, ETHNIC ORIGIN, SEXUAL ORIENTATION, PHYSICAL OR MENTAL HANDICAP, OR SOURCE OF PAYMENT.
2. RECEIVE CONSIDERATE AND RESPECTFUL CARE BY EACH INDIVIDUAL REPRESENTING TILLGES CERTIFIED ORTHOTIC PROSTHETIC INC.
3. BE FULLY INFORMED AS TO OUR COMPANY POLICIES AND PROCEDURES REGARDING BILLING AND COLLECTION OF ACCOUNTS.
4. PARTICIPATE IN DECISIONS REGARDING HIS/HER OWN TREATMENT, INCLUDING ESTABLISHMENT OF GOALS AND EXPECTED OUTCOMES.
5. EXPECT REASONABLE RESPONSES TO HIS/HER REQUESTS AND CONCERNS.
6. BE ASSURED OF CONFIDENTIAL TREATMENT OF HIS/HER PERSONAL AND MEDICAL RECORDS, AND THE RIGHT TO REVIEW RECEIVE COPIES OF HIS/HER RECORDS.
7. PROMPT SERVICE IN THE EVENT THAT AN ORTHOSIS OR PROSTHESIS IS IN NEED OF IMMEDIATE REPAIR OR REPLACEMENT. SUCH SITUATIONS RECIEVE THE HIGHEST PRIORITY AND EVERY EFFORT IS MADE TO RESOLVE THE SITUATION IN THE SHORTEST PERIOD OF TIME POSSIBLE. **PATIENTS MAY CALL OUR OFFICE AT ANY TIME WITH SUCH NEEDS. A PRACTITIONER IS ON CALL AT ALL TIMES AFTER NORMAL BUISNESS HOURS.**
8. BE FULLY INFORMED OF MEDICARE SUPPLIER STANDARDS THAT APPLY TO OUR BUSINESS. (THESE ARE POSTED IN WAITING AREA AND INDIVIDUAL COPIES ARE AVAILABLE AT OUR FRONT DESK)

WARRANTY – OUR PLEDGE TO YOU

Tillges Certified Orthotic Prosthetic Inc. pledges to provide its patients with product and devices of the highest quality, free of defects and according to the patient's prescription.

Tillges Certified Orthotic Prosthetic Inc. will warranty *custom* orthoses and prostheses for a period of 90 days. Any adjustments during that period not due to physical changes of the patient, or abuse or undue rough wear, will be made free of charge. Custom fabricated devices cannot be returned for credit on your account.

“Off-the-shelf” items cannot be returned for hygienic reasons. In the unlikely event of an off-the-shelf item having a defect, *only the manufacturer's warranty applies*. We will contact the manufacturer on your behalf during the initial 90 day warranty period after delivery of your off the shelf product.

It is in your best interest to communicate with your practitioner on a timely basis and to allow us to resolve any problems you are experiencing as efficiently and quickly as possible. Failure to contact the treating practitioner or infrequent or non-use of a device during the warranty period does not extend the warranty nor does it absolve the patient from the responsibility for payment.

It is our goal to provide you with the best care possible, and we will make every attempt to meet your need. Please contact us if there is a question or concern. We stand by our work.

TILLGES CERTIFIED ORTHOTIC PROSTHETIC BILLING AND COLLECTION POLICY

In order to ensure that each patient has adequate information to make an informed decision about treatment, Tillges Certified Orthotic Prosthetic Inc. is providing this information about its billing and collection policies.

1. There is no charge for an initial evaluation appointment with a practitioner. Upon completion of the initial evaluation appointment, each patient meets with our office personnel to go over the following:
 - a. Total cost of the item being provided.
 - b. Copay or coinsurance estimate as determined per our call to the patient's insurance company.
 - c. The copay, coinsurance or any other amount not covered by insurance becomes the patient's responsibility at the time of the fitting appointment.
 - d. A payment plan is available, if needed, requiring 1/3 down, 1/3 in a month, and final 1/3 in two months.
 - e. Unless the order is cancelled within 24 hours of the evaluation, the patient is responsible for the payment for the work performed regardless of whether or not the patient picks up the product/device or schedules a fitting. (Patients are called a minimum of 3 times to inform them that their product/device is available.)
 - f. The insurance company will be billed by Tillges Certified Orthotic Prosthetic Inc., including patient's secondary insurance and follow up on denials, if requested. Note: Care is provided to the patient, not to an insurance company, thus the insurance company is responsible to the patient and the patient is ultimately responsible to see that the insurance company pays on their claims. We will help by filing the claim on the patient's behalf and answering insurance questions, but ask that the patient follow up with the insurance company if they do not pay the claim within 90 days.
2. Monthly statements are sent to patients with an indication that the insurance has been billed and a comment regarding payment if applicable.
3. A second monthly statement will be stamped "Past Due."
4. A third monthly statement will be stamped "Final Notice."
5. After internal steps have been taken and if no payment plan has been setup and no payments have been received, the account is turned over to a collection agency. All collection fees incurred by Tillges Certified Orthotic Prosthetic Inc. will be passed onto the patient.

WHAT GOES INTO THE COST OF MY ORTHOSIS/PROSTHESIS?

- The appropriate design and precise fitting of your orthosis or prosthesis requires the skills of a highly trained practitioner. Orthotists and Prosthetists have completed a minimum of six years of higher education, and a one-year residency for each discipline. In addition, all of our Practitioners are certified by the American Board of Certification in Orthotics & Prosthetics (ABC) or are pursuing certification. Our facility is also accredited by ABC. Please see brochures in our lobby, which explain the requirements and merit of these certifications.
- Continuing Education for Practitioners and Technicians, and membership in various professional organizations keep our staff current on the latest technology in our field. Robert Tillges, CPO, FAAOP, is a Fellow in the American Academy of Orthotists and Prosthetists, the highest achievement in continuing education in our industry.
- As a clinic and a fabrication lab, our costs include specialized machinery, materials and supplies for fabrication, as well as ordinary office overhead. There is also a growing cost associated with compliance with a variety of federal and state regulations.
